

Gas Resource Cost Adjustment for August 2019 Gas Rates

Osaka Gas Co., Ltd.

Osaka Gas Co., Ltd. (President: Takehiro Honjo) will lower its city gas unit rates, which will be applied to the regulated charges under the General Gas Supply Provisions*¹ and unregulated charges,*² for August 2019 meter reading by 2.36 yen/m³ (tax included) from those for July 2019 meter reading. The decrease reflects the adjustment of gas resource costs based on the average gas resource price of March to May 2019 (57,620 yen/ton). The adjustment will lower the monthly gas rate for the standard household by 73 yen (tax included).

1. Calculation of the adjustment amount of the unit rate for the month

(Average gas resource price) (Base average gas resource price) (Difference)

$$57,620 \text{ yen/ton} - 64,090 \text{ yen/ton} = -6,470 \text{ yen/ton}$$

$$-6,470 \text{ yen/ton} \div 100 \text{ yen/ton} = -64.7 \rightarrow -64 \text{ (figures after the decimal fractions omitted)}$$

$$-64 \times 0.081 \times (1 + 0.08) = -5.59872 \rightarrow -5.60 \text{ yen/m}^3 \text{ (the third decimal place rounded up)}$$

(Consumption tax) (Adjustment amount for the month)

$$-5.60 \text{ yen/m}^3 - (-3.24 \text{ yen/m}^3) = -2.36 \text{ yen/m}^3$$

(Adjustment amount for the month) (Adjustment amount for the previous month) (Difference from the previous month)

August 2019 gas rate (tax included) for the standard household is calculated as follows:

$$1,340.00 \text{ yen/month} + (141.90 \text{ yen/m}^3 + (-5.60 \text{ yen/m}^3)) \times 31 \text{ m}^3/\text{month}$$

$$= 5,565 \text{ yen/month (figures after the decimal fractions omitted)}$$
