Gas Resource Cost Adjustment

for December 2019 Gas Rates

October 30, 2019 Osaka Gas Co., Ltd.

Osaka Gas Co., Ltd. (President: Takehiro Honjo) will lower its city gas unit rates, which will be applied to the regulated charges under the General Gas Supply Provisions^{*1} and unregulated charges,^{*2} for December 2019 meter reading by 0.18 yen/m³ (tax included) from those for November 2019 meter reading. The decrease reflects the adjustment of gas resource costs based on the average gas resource price of July to September 2019 (53,750 yen/ton). This adjustment will lower the monthly gas rate for the standard household by 5 yen (tax included).

53,750 yen/ton - 64,090 yen/ton = -10,340 yen/ton

-10,340 yen/ton ÷ 100 yen/ton = -103.4 -> -103 (figures after the decimal fractions omitted)

 $(Consumption tax) (Adjustment amount for the month) -103 \times 0.081 \times (1 + 0.1) = -9.1773 -> -9.18 \ yen/m^3 \ (the third decimal place rounded up)$

Basic charge + (Base unit rate + unit meter rate adjustment amount) × Average monthly usage at standard household 1,364.81 yen/month 144.52 yen/m³ -9.18 yen/m³ 31 m³/month

= 5,560 yen/month (figures after the decimal fractions omitted)
