Gas Resource Cost Adjustment for February 2020 Gas Rates

December 26, 2019 Osaka Gas Co., Ltd.

Osaka Gas Co., Ltd. (President: Takehiro Honjo) will lower its city gas unit rates, which will be applied to the regulated charges under the General Gas Supply Provisions*¹ and unregulated charges,*² for February 2020 meter reading by 0.71 yen/m³ (tax included) from those for January 2020 meter reading. The decrease reflects the adjustment of gas resource costs based on the average gas resource price of September to November 2019 (52,620 yen/ton). This adjustment will lower the monthly gas rate for the standard household by 22 yen (tax included).
