Osaka Gas Co., Ltd. (President: Takehiro Honjo, hereinafter, "Osaka Gas") today announced that it had acquired the shares of Global Base Corporation (President: Keiichiro Mogi, hereinafter, "Global Base"), which operates in the renovation field mainly in the Tokyo metropolitan area, on May 1, 2020. Global Base will strengthen its business mainly in the Tokyo metropolitan area to achieve further growth as a member of the Daigas Group.

In the Tokyo metropolitan area, the supply of new condominium units is expected to decrease due to surging prices and other factors. Meanwhile, the growth of the used condominium market has attracted much public attention. Global Base launched its business to renovate used condominiums in 2002. It has a competitive edge in its capability to procure properties in attractive locations and to undertake design and construction projects that meet various customer needs.

The cumulative total of units sold in the Tokyo metropolitan area has reached about 3,800. In recent years, Global Base has also focused its resources on offering additional services and differentiating from its competitors in space design through collaboration with partners in other industries to offer more comfortable living spaces.

It will also strengthen its renovation capability by proposing the latest IoT-based gas appliances to offer new services to customers.
