

# Gas Resource Cost Adjustment for September 2020 Gas Rates

Osaka Gas Co., Ltd.

Osaka Gas Co., Ltd. (President: Takehiro Honjo) will lower its city gas unit rates, which will be applied to the regulated charges under the General Gas Supply Provisions\*<sup>1</sup> and unregulated charges,\*<sup>2</sup> for September 2020 meter reading by 2.14 yen/m<sup>3</sup> (tax included) from those for August 2020 meter reading. The decrease reflects the adjustment of gas resource costs based on the average gas resource price of April to June 2020 (49,980 yen/ton). This adjustment will lower the monthly gas rate for the standard household by 66 yen (tax included).

## Exhibit

### 1. Calculation of the adjustment amount of the unit rate for the month

(Average gas resource price) (Base average gas resource price) (Difference)

$$49,980 \text{ yen/ton} - 64,090 \text{ yen/ton} = -14,110 \text{ yen/ton}$$

$$-14,110 \text{ yen/ton} \div 100 \text{ yen/ton} = -141.1 \rightarrow -141 \text{ (figures after the decimal fractions omitted)}$$

(Consumption tax) (Adjustment amount for the month)

$$-141 \times 0.081 \times (1 + 0.1) = -12.5631 \rightarrow -12.57 \text{ yen/m}^3 \text{ (the third decimal place rounded up)}$$

(Adjustment amount for the month) (Adjustment amount for the previous month) (Difference from the previous month)

$$-12.57 \text{ yen/m}^3 - (-10.43 \text{ yen/m}^3) = -2.14 \text{ yen/m}^3$$

September 2020 gas rate (tax included) for the standard household is calculated as follows:

$$\begin{array}{r} \text{Basic charge} + (\text{Base unit rate} + \text{unit meter rate adjustment amount}) \times \text{Average monthly usage at standard household} \\ 1,364.81 \text{ yen/month} \quad 144.52 \text{ yen/m}^3 \quad -12.57 \text{ yen/m}^3 \quad \times \quad 31 \text{ m}^3/\text{month} \end{array}$$

= 5,455 yen/month (figures after the decimal fractions omitted)
