# Gas Resource Cost Adjustment for January 2021 Gas Rates

November 27, 2020 Osaka Gas Co., Ltd.

Osaka Gas Co., Ltd. (President: Takehiro Honjo) will lower its city gas unit rates, which will be applied to the regulated charges under the General Gas Supply Provisions\*1 and unregulated charges,\*2 for January 2021 meter reading by 2.41 yen/m³ (tax included) from those for December 2020 meter reading. The decrease reflects the adjustment of gas resource costs based on the average gas resource price of August to October 2020 (32,160 yen/ton). This adjustment will lower the monthly gas rate for the standard household by 75 yen (tax included).
