Invests in D&D Solar GK and Acquires a Solar Power Plant in Izumi City, Kagoshima Prefecture, Through D&D Solar GK

Osaka Gas Co., Ltd. (President: Takehiro Honjo, hereinafter "Osaka Gas") and Development Bank of Japan Inc. (President and CEO: Hajime Watanabe, hereinafter "DBJ") invested*1 in D&D Solar GK (hereinafter "D&D Solar"), which was established to hold solar power asset. Today, Osaka Gas and DBJ acquired a solar power plant owned by BayWa r.e. Solar Projects GmbH, a German company, in Japan through D&D Solar as its first solar asset.

This power plant is Kuwaharajyou Mega Solar (No. 4), which is being operated in Izumi City, Kagoshima Prefecture. Its installed capacity is about 12 MW.

The Daigas Group considers renewable energy as an important energy source in the future and aims to develop and acquire renewable power sources^{*2} of more than 1,000 MW in and outside Japan by FY2030. With this power plant included, the group develops and operates renewable power sources equivalent to 710 MW.*3

DBJ will promote a green growth strategy to achieve carbon neutrality by 2050 by supplying risk money to renewable power sources, such as photovoltaic power generation and wind power generation projects in and outside Japan.

Osaka Gas and DBJ will continue to expand renewable energy capacity, including acquisition of solar power asset through D&D Solar, by effectively combining Osaka Gas's expertise in the renewable energy business with DBJ's expertise in financing.


