# Gas Resource Cost Adjustment for July 2021 Gas

May 28, 2021 Osaka Gas Co., Ltd.

Osaka Gas Co., Ltd. (President: Masataka Fujiwara) will lower its city gas unit rates, which will be applied to the regulated charges under the General Gas Supply Provisions\*<sup>1</sup> and unregulated charges\*<sup>2</sup> for July 2021 meter reading by 0.09 yen/m³ (tax included) from those for June 2021 meter reading. The decrease reflects the adjustment of gas resource costs based on the average gas resource price of February 2021 to April 2021 (47,080 yen/ton). This adjustment will lower the monthly gas rate for the standard household by 3 yen (tax included).

## July 2021 regulated charges under the General Gas Supply Provisions (tax included)

## 1. Calculation of the adjustment amount of the unit rate for the month

July 2021 gas rate (tax included) for the standard household is calculated as follows:

Basic charge + (Base unit rate + unit meter rate adjustment amount) × Average monthly usage at standard household 1,364.81 yen/month 144.52 yen/m³ -15.15 yen/m³ 31 m³/month

= 5,375 yen/month (figures after the decimal fractions omitted)
