## Osaka Gas to Offer New Gas Rate Plans for Household Use

February 28, 2022 Osaka Gas Co., Ltd.

Osaka Gas Co., Ltd. (President: Masataka Fujiwara) will add new rate plans for household use to the Gas Toku Plan on April 1, 2022, and start accepting sign-ups for them on March 1, 2022.

Osaka Gas has provided the Gas Toku Plan, which offers customers discounted rates based on gas equipment and amount used. Along with its entry into the fixed-line telecommunications business in March, Osaka Gas will modify its rate plans to further benefit customers if they sign a package deal contract of gas and electricity/Internet with the company. Osaka Gas will also launch rate plans for customers who use a gas clothes dryer or a gas bathroom heater/dryer.

Because of the launch of these new rate plans, after the end of March 2022, Osaka Gas will no longer accept new sign-ups for its conventional Motto Wari, , Yukadan and Mai Homu Hatsuden rate plans. Note that customers who have already signed up for these conventional rate plans may keep using them even after April 2022.

The Daigas Group will continue to diversify its rate plans according to customer needs and aim to become an energy marketer of the new era that will be continuously chosen by customers through the provision of high-quality, safe, and secure services to ensure safe use of energy and service plans that are useful for the lives and businesses of customers.

\*1 The gas rates are based on the unit rates as of January 2022 and include the amounts equivalent to consumption tax, etc. The charge for the Matome Toku Plan, the Motto Matome TokuPlan, the Kaji Toku, or the Suma-to Hatsuden Plan for a month may sometimes be higher than that for the Ippan Plan.

\*2 This is an example estimate based on a comparison in the amount to be charged to a user of Osaka Gas's gas (annual usage 600 m<sup>3</sup>) and either Osaka Gas's electricity or Internet between the Matome Toku Plan (annually about 99,000 yen) and the Ippan Plan (annually about 102,000 yen).

\*3 This is an example estimate based on a comparison in the amount to be charged to a user of Osaka Gas's gas (annual usage 600 m<sup>3</sup>) and both Osaka Gas's electricity and Internet between the Motto Matome Toku Plan (annually about 96,000 yen) and the Ippan Plan (annually about 102,000 yen).

\*4 This is an example estimate based on a comparison in the amount to be charged to a user of a gas clothes dryer (annual usage 656 m<sup>3</sup>) between the Kaji Toku (annually about 99,000 yen, with an 8% optional discount applied) and the Ippan Plan (annually about 110,000 yen).

\*5 This is an example estimate based on a comparison in the amount to be charged to a user of a gas-fueled hot-water radiant floor heating system (annual usage 813 m<sup>3</sup>) between the Attame Toku Plan for ECO-JOZU (annually about 109,000 yen, with a 9% optional discount applied) and the Ippan Plan (annually about 132,000 yen).

\*6 This is an example estimate based on a comparison in the amount to be charged to a user of ENE-FARM (annual usage 1,630 m<sup>3</sup>) between the Sumato Hatsuden Plan (annually about 159,000 yen, with a 9% optional discount applied) and the Ippan Plan (annually about 243,000 yen).

\*7 Users of the Attame Toku Plan or the Suma-to Hatsuden Plan may combine up to three optional discounts that sum up to 9% at the maximum.

\*8 Users of the Suma-to Hatsuden Plan may receive the discount on a gas bathroom heater/dryer only when they use both the gas bathroom heater/dryer and a gas-fueled hot-water radiant floor heating system.
