# Gas Resource Cost Adjustment for January 2023 Gas Rates

November 29, 2022 Osaka Gas Co., Ltd.

Osaka Gas Co., Ltd. (President: Masataka Fujiwara) will revise its city gas unit rates as follows, which will be applied to general charges for the January 2023 meter reading, on the basis of the average gas resource price between August 2022 and October 2022.

This adjustment will raise the monthly gas rate for the standard household by 334 yen (tax included).

Please also note that the average gas resource price has exceeded its ceiling price (127,640 yen/ton), which is applied to the January 2023 meter reading. Therefore, the adjustment is made on the basis of the average gas resource price of 127,640 yen/ton.

# 3. The gas rate for the standard household for January (tax included) is calculated as follows.
