

Osaka Gas to collaborate with Santos, Tokyo Gas, and Toho Gas in producing e-methane in Australia and exporting it to Japan

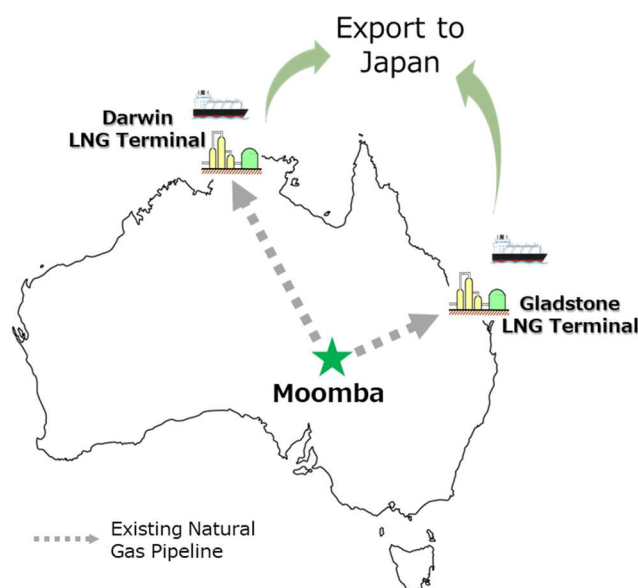
Osaka Gas Co., Ltd. (Osaka Gas) today announced that its wholly owned subsidiary, Osaka Gas Australia Pty Ltd (OGA), has entered into an agreement with Santos Ventures Pty Ltd, Santos Ltd's (Santos) wholly owned subsidiary, Tokyo Gas Co., Ltd., and Toho Gas Co., Ltd. to conduct Pre-Front End Engineering and Design (Pre-FEED) work to produce e-methane,¹ a carbon-neutral synthetic methane, at Moomba in the Cooper Basin, located in the central part of Australia.

Under the agreement, OGA and its partners will conduct technical, regulatory, and commercial studies to produce 130,000 tons (180 million Nm³/year) or more of e-methane annually at Moomba, an area where Santos has been developing and operating natural gas fields for many years. The studies will also explore exporting the above amount of e-methane to Japan. The partners aim to commence e-methane production and export by 2030 at the earliest.

For this Pre-FEED initiative, Osaka Gas has secured a subsidy² of Japan's Ministry of Economy, Trade, and Industry.

- 2 The subsidy granted during the fiscal year 2024 to eligible applicants involved in projects with the following objectives:
 - Decarbonizing and reducing carbon emissions from fossil-fuel-related facilities and equipment in resource-producing countries
 - Investigating and researching potential initiatives to implement Japanese state-of-the-art technologies related to hydrogen, ammonia, biofuel, and other fuels to decarbonize and reduce carbon emissions in the fossil fuel industry of resource-producing countries.
