

**Acquisition of Business from the Fasttrack Solutions Inc.  
Group, a Provider of Enterprise Resource Planning (ERP)  
solutions in the Philippines**

OGIS-RI Co., Ltd. (Representative Director and President: Kazuhiko Yoshimura, hereinafter “OGIS-RI”), a wholly owned subsidiary of Osaka Gas Co., Ltd. (Representative Director and President: Masataka Fujiwara), will acquire the entire business of the Fasttrack Solutions Inc. Group (hereinafter “FT Group”) as of February 1, 2025, through OGIS Philippines, Inc. (hereinafter “OGIS-PH”), which was established in November 2024. The FT Group provides implementation and operational support for packaged Enterprise Resource Planning (ERP) solutions in the Southeast Asian region, mainly in the Philippines. With this acquisition, OGIS-RI will commence ERP business operations in the Philippines and other Southeast Asian countries.

The OGIS-RI Group provides comprehensive service, from the development to the operation of mission-critical systems of the Daigas Group, as well as a wide range of services to customers outside the Daigas Group. As a system that centralizes the management of corporate activities and contributes to efficient business operations, ERP packages are being adopted across a wide range of industries. Supporting the implementation of these packages is one of the core businesses of the OGIS-RI Group.

With the aim of expanding its ERP business, OGIS-RI has been growing its scale and scope of ERP operations by welcoming Agnie Consulting Corporation, a company specializing in ERP implementation consulting, into the group in October 2017, and AMMIC Corporation, which develops and offers the STRAMMIC series of ERP packages for the manufacturing industry, in January 2023. As the next step, OGIS-RI has been exploring opportunities for overseas expansion.

Since its founding in 2005, the FT Group has been providing implementation support, as well as operation, maintenance, cloud hosting, and data analytics services for ERP packages, including SAP and NetSuite. It is one of the leading companies in ERP package implementation support in the Philippines. Leveraging its extensive range of solutions and expertise gained from a broad track record across various industries and companies, the FT Group has been growing its business with a strategy focused on enhancing cloud-based solutions.

With this acquisition, the OGIS-RI Group will expand the target market of its ERP business, which has been growing domestically, into overseas markets. By combining its strengths in technology and project management with the FT Group's extensive range of solutions and industry-specific expertise, the OGIS-RI Group will enhance its operations to provide solutions that meet the broad needs of large to small and medium-sized enterprises across Southeast Asia, including the Philippines.

The Daigas Group aims to evolve the management of its business portfolio, which consists of the “Domestic Energy Business,” “Overseas Energy Business,” and “Life & Business Solutions (LBS) Business.” As part of the LBS business, the OGIS-RI Group's “Information Business” provides high-value-added services utilizing digital technologies and seeks to expand its scope and scale.

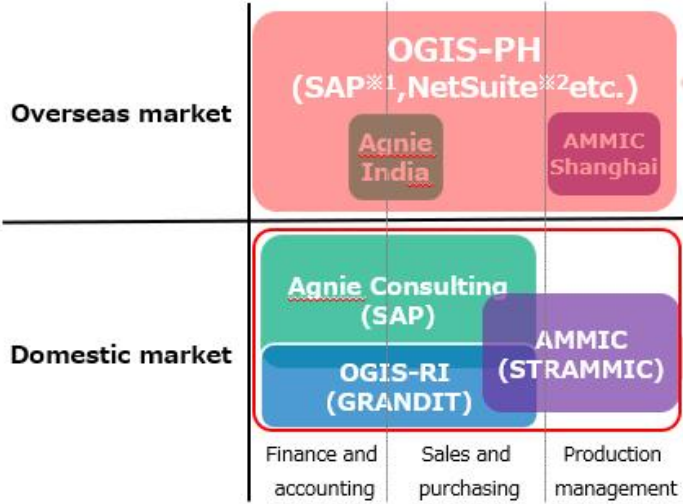
