

Gas Resource Cost Adjustment for March 2025 Gas Rates

January 30, 2025 Osaka Gas Co., Ltd.

Osaka Gas Co., Ltd. (President: Masataka Fujiwara) will adjust its city gas unit rates as follows, which will be applied to general charges for the March 2025 meter reading. These changes are made based on the average gas resource price between October 2024 and December 2024 and in consideration of a government measures to subsidize electricity/gas rates.*1 The gas fee for a standard household for this month will be 6,205 yen (including tax) by this adjustment.

Details of the average gas resource prices used in the calculation of the unit price of the gas resource cost adjustment for general charges (yen/ton)

2. The unit price of the gas resource cost adjustment for general charges for the month is calculated as follows.

(Average gas resource price) (Base average gas resource price) (Difference)

83,080 yen/ton - 64,090 yen/ton = 18,990 yen/ton

18,990 yen/ton \div 100 yen/ton = 189.9 \rightarrow 189 [Decimal fractions omitted]

(Consumption tax) (Unit price of gas resource cost adjustment for the month) $189 \times 0.081 \times (1 + 0.1) = 16.8399 \rightarrow 16.83 \text{ yen/m}^3 \text{ [Rounded down to two decimal places]}$

3. The gas rate for the standard household for the month (tax included) is calculated as follows.

Basic charge + (Base unit rate + Unit price of gas resource cost adjustment) × Monthly usage at standard household $1,364.81 \text{ yen/month} + (144.52 \text{ yen/m}^3 + 16.83 \text{ yen/m}^3) \times 30 \text{ m}^3/\text{month} = 6,205 \text{ yen/month}$ [Rounded down to the nearest yen]
